BY-LAW NO. 3-80

A BY-LAW OF THE MUNICIPALITY OF *ARROOSTOOK*
RESPECTING THE COMPOSITION OF THE COUNCIL AND
THE REMUNERATION OF THE MAYOR AND THE COUNCILLORS

THE COUNCIL OF THE MUNICIPALITY OF *ARROOSTOOK*

DULY ASSEMBLED HEREBY ENACTS AS FOLLOWS:

1. The council consists of
 - (a) a mayor, and
 - (b) *FIVE* (~~two or more~~) councillors.
2. (1) The salary of the mayor is *\$350.00* dollars per year payable monthly in equal installments provided however, that if the mayor is absent from a regular council meeting, the clerk shall deduct *NIL* dollars from the salary unless the mayor is excused for reasonable cause by resolution of the council.
 - (2) The salary of each councillor is *\$250.00* dollars per year payable monthly in equal installments provided however, that if a councillor is absent from a regular council meeting, the clerk shall deduct *NIL* dollars from his salary unless the councillor is excused for reasonable cause by resolution of the council.
 - (3) In addition to the salary provided for in subsection (1), the allowance of the mayor for expenses incidental to the discharge of his duties as mayor is *Per RECEITS* dollars payable monthly in equal installments.
 - (4) In addition to the salary provided for in subsection (2), the allowance for each councillor for expenses incidental to the discharge of his duties as councillor is *Per RECEITS* dollars payable monthly in equal installments.

To be Enacted upon the date of the next Triennial Election.




